 - o There is now another vacancy on the board

Work Session with Tracy Cook and Cara Orban, Montana State Library

Library District

- Goals for Today:
 - o Decide if we go for a district again or mill levy
- Notes
 - Voter feedback/data collection
 - How many people didn't vote b/c it was on the back of the ballot?
 - How many people thought it was in November?
 - o People reported that they did not receive their postcards in the mail
 - Annie was handing out tons of postcards at the Farmer's Market b/c they didn't receive theirs
 - o Ballot language
- Great Falls Public Library—very contentious mill levy campaign
 - Hired an outside firm to direct messaging and get good data to help make decisions along the way
 - Would the Foundation be able to support us in this?
 - o Hire an election monitor
- District is the better option
 - o Work on messaging based on location, use, gains, etc.
 - o Have to do same ask again
 - o Need to get voter feedback and regroup/restrategize before going again
 - o Being in on a primary election or special election is best
- Campaigning
 - o Small group meetings/discussions were more productive
 - This campaign was a big hurdle because people did not know about the financial problems facing the county and the library—a lot of education up front
 - Far out places like Happy's Inn, do not see the impact of the library in their lives—Kalispell is closer
- Why did the library work?
 - People need the library no matter what—it is always there no matter your age or place in life
 - like what the library is doing
 - the library is not political
 - library staff
 - clear and consistent messaging
 - people getting to meet the trustees
 - yard signs, mailer, newspaper ads—got the information out there
- To Do:
 - o Voter reconnaissance—data and information gathering (market research)
 - What do we want to know?
 - o How to adjust messaging?
 - o Get 'yes' voters to help us
 - o Which election are we going to go for?
 - Would the commissioners be willing to do a resolution again?
 - Meetings with commissioners about their role in campaigning

District committee—Who will do each task?

FY25 Budget

- 8 budget options presented depending on mills available
- We will need to get clarification from commissioners on exact funding
- Options for rehiring for Dusty's position or ramifications for not filling that position; fill at ½ time?
- Reducing open hours but having staff have same hours to be able to accomplish administrative tasks while in keeping county requirements (at all branches)
- Apply for deferment with State Library for not meeting the standard for required hours open—we will have to show proof of efforts to meet those hours
- Potential closures could happen beginning in August (closing the basement, during lunch, one day a week) –will be saving some money in the interim by not rehiring
- Still planning to rehire a full time for fear of losing entire position
- Volunteers are difficult to utilize because they need to be consistent/reliable –best if used for a one-time opportunity and not weekly programming
- Need to make a decision regarding staffing/closures at next meeting
- Need to get question answered on permissive tax funding because it will effect our budget—commissioners will not know about the budget until August—Barb will speak to Teske to start
- Option 1 and 1-A are operating with half of our book budget
